- 1. Copies of business registration certificate
- 2. Company profile including Postal, physical and email address and phone numbers
- 3. Tax Payment Identification Certificate (TPIN)
- 4. Evidence of Previous Contracts (within the last two years). Note that Orant Charities Africa reserves the right to contact referees as may become necessary without the bidder's knowledge.
- 5. Registration with the Ministry of Trade if it is a Micro and Small Medium Enterprise (MSME).
- 6. Full banking details
- 7. Any terms and conditions (e.g., bulk purchase discount, and delivery terms and conditions)

## **Notes**

- 1. Suppliers can bid for one or more lots.
- 2. Participation is open and on equal terms to all prospective suppliers.
- 3. Pre-qualification awarding will be based on legal compliance, establishment, quality, track record and financial capacity among others.
- 4. Interested Suppliers must be willing to deliver the services or products in Kasese, Dowa.
